Important Information Regarding Pension Contributions from Loyce Swartz Borgmann, Assistant Director of Client Relations

September 24, 2015

Dear District Executives,

We are aware that many churches are working on budgets right now and this will be the first time working with the changed insurance premium provisions. We realize that pastoral salaries and benefits will be reviewed during this process and that numbers may be reworked. We need your help in letting pastors and churches know that if any change is made in pension contributions, they need to let BBT know so that we can change their supplement agreement that allows the church to remain in compliance. This is important because failure to maintain compliance with the plan document could result in the church's plan losing its tax-qualified status and all accumulations in that plan become immediately taxable.

This also seems to be a good time to remind you about pension supplements with regards to pastoral placement. At this point, each church has its own supplement agreement. If you are negotiating with a new pastor, you need to be aware of what the current pension supplement agreement states. If the new pastor and congregation decide to vary from the current supplement agreement, they need to notify BBT so that we can change the supplement agreement, thus allowing the church to remain in compliance.
