Please complete and return a signed copy of the appropriate Renewal Agreement to the District Office no later than **December 31, 2016.** This is an important document for your insurance, pension, and ministry records.

### Self-Allocation Packets

Each church should have received 3 self-allocation packets (for Pastor, Board Chair, Treasurer/Finance Chair) containing information on each of the denominational agencies and worksheet for budgeting outreach for 2017. These were distributed at District Conference and mailed to those who didn't pick them up there. This includes giving to the District, Inspiration Hills, the Brethren Homes, as well as to the denomination. Please prayerfully consider your giving to the broader church as you plan your budget for 2017.

We are requesting that allocated money be sent directly to each receiving agency – rather than to the District Office to distribute. Mailing labels were included with packets. They are also attached in electronic form to this Pastors Memo for printing. This will streamline the work of our volunteer treasurer and financial secretary and streamline the process.
