## 2017 Clergy-Spouse Retreat February 19-21 Holiday Inn French Quarter, Perrysburg, Ohio

Plan on joining us for the upcoming Clergy-Spouse Retreat February 19-21, 2017 at the Holiday Inn French Quarter, Perrysburg, OH. The theme for the retreat is “Tethered Freedom” (Psalm 78). Our guest speaker will be Jason Barnhart. Jason serves as the University Chaplain at Ashland University in Ashland, Ohio. He is currently completing doctoral work at La Salle University where he is studying Brethren historical theology. Jason is originally from McGaheysville, Virginia, but came to Ashland to attend Ashland University ('04) and then Ashland Theological Seminary ('08). An elder in the Brethren Church, Jason has a passion for the intersection of Brethren thought with current events finding the Brethren way to be a critical voice in American Christianity. He co-edited a book in 2014 entitled, *A Brethren Witness for the 21st Century*, which brought various Brethren voices together to discuss the historic values of the Brethren movement. He is currently working on a biography of Brethren elder J. Allen Miller. Jason and his wife, Allison (AU, '06), reside in Ashland with their two children,

Miles (age 7) and Clementine (age 4).

Brethren are a people that look out for the next generation—but what does this look like and how is it central to our witness as a people?

Jason will help participants reflect on the intergenerational truths and challenges of Psalm 78. Participants will reflect on those that poured into their lives, identify next generation leaders to journey alongside, and explore how these two paths are interwoven in their respective callings. Young and old will discover that while the church growth movement made the separation of generations a preferred strategy, our future as Brethren depends on how the generations come together to model family to a disconnected world. 

### **Terry Vaught Called As Pastor at Paradise**

Terry Vaught had been serving as interim at Paradise Church of the Brethren for several months when the congregation extended the call for him to become the pastor. The installation service was held on December 4th amidst a time of celebration and conversation about the direction of the church in the months to come. Terry most recently served at Pastor of Visitation of Maple Grove. Terry, his wife Sherry (also an ordained minister) have one son, Reese.



Jesus teaches that the greatest commandments are, first to love the Lord your God with all your heart, soul, and mind; and second to love your neighbor as yourself (Luke 10:27). He then adds that loving only your neighbor is not enough. We are to love our enemies as well (Matthew 5:43-45a). These teachings are at the core of Jesus' message and ministry. We are called to do as he did. To strive to be perfect as Jesus was perfect. That is to, in the manner of our living, be the hands and feet of Jesus in the world. We have a powerful message to share with a needy world. It is a message of salvation, of covenant relationship with Christ, of oneness with all the people God created. It is a message of peace.

The concept of 'peace' in the Bible has a broad range of meanings. The Hebrew word Shalom, includes well-being, health, unity, abundance, wholeness, fullness of life and the absence of war or violence. It also includes being in harmony with creation. That peace comes from God is clear (Ezekiel 34:24-27). It comes when God and his people are in a covenant relationship with each other. When the people break the covenant, peace is lost.

Jesus came into the world as the prince of peace to offer a new covenant that will restore the relationship between God and those who covenant with him (Romans 5:1). Unlike in the Old Testament when the identity of 'God's people' was narrowly defined, the new covenant in Jesus is offered to all people (Ephesians 2:13-22).

Entering into covenant with Christ affects our relationships with people as well – all people, not just those who also follow Christ. Accepting this covenant - being in right relationship with Christ makes us one with each other across the lines of race, class, nationality and anything else that can separate people. Living in this covenant relationship - that is peace (Colossians 3:15; Romans 12:18; II Corinthians 13:11).

### **Peacemaking Resources:**

- District **Shalom Team** is called to help people resolve conflicts when they arise and prevent division and brokenness. Shalom Teams look to Matthew 18 to provide a framework for addressing conflict within the church. (Contact the District Office for more information.)
- The **Peace Task Team** works with the District Peace & Conciliation Advocate to plan peace education programming in the District. (For more information contact Linda Fry, District Peace & Conciliation Advocate.)
- The **Peace and Conciliation Advocate** works with pastors, congregations, and the District youth to help people of all ages learn peacemaking skills including Biblical peace principles, listening skills, conflict resolution skills.
  - Works with the Peace Task Team and Shalom Team
  - Is available to preach and leads workshops when asked (see contact information below)
  - creates peace education materials for all ages. A list of available resources is available upon request.
  - publishes the quarterly *Peace Advocate News*. It is mailed to pastors, church board chairs, congregational peace representatives, district board members, all Church of the Brethren camps (at their request), some other Church of the Brethren leaders. Anyone can receive a copy upon request. It is also posted on the district website. Back issues are available.

# Updates for a New Year

“And now we welcome the new year. Full of things that have never been.” (Rainer Maria Rilke) This year does promise to be full of things that are new to us: in our culture and in the church, some that bring challenge and fear, some that bring hope and light. But the love and strength that is ours in Christ remains constant!

Within our District, the Search Committee works towards choosing a District Executive. Money from the Hottle gift has been freed up to allow more churches to dream of what might be in terms of outreach ministries. Our District Board and staff work towards resourcing our churches, a number of which are struggling.

Within the denomination, this will be a year of challenge. Delegates at Annual Conference took the following action related to the query on same sex weddings:

“Query: Same Sex Weddings The 2016 Annual Conference adopted a motion from the floor to refer the concerns of the query to the Leadership Team in consultation with the Council of District Executives to bring clarity and guidance concerning the authority of Annual Conference and districts regarding the accountability of ministers, congregations, and districts, bringing recommendations to the 2017 Annual Conference.”

The Council of District Executives (CODE) Executive Committee and leadership team have met on this issue. The full CODE (including myself) and leadership team will meet at the end of January to make decisions on what to bring to Annual Conference in 2017. There is great theological diversity around the CODE table. There is also a strong commitment to something more than a recommendation for more study or more time.

The light is more easily seen in the darkness, and so times of fear and change are also times of hope and renewal. I ask that we continue to surround our churches, our district, and our denomination with prayer. It is our great and powerful God that sees way past our own understanding of possibilities. May we be faithful as we seek his face, continuing the work of Jesus to bring light and life to the world.

My prayer for each of you – and for all of us together – as a new year begins comes from Romans 15:13. **“May the God of hope fill you with all joy and peace as you trust in him, so that you may overflow with hope by the power of the Holy Spirit.”**
