District Conference edition of the Herald

Distributing the Herald – seeking ideas

We are seeking feedback on the best way for the Herald to be distributed to the congregations so that individuals can receive the information. We do not have enough information to mail copies to each church member's home. We also know that sometimes stacks of unused Herald's sit on a back table only to be thrown away when the next one arrives. Please call/email the District Office with any thoughts you may have so that this important connection with the District can be maintained in an effective way.

Did you know?

The District website provides a web presence for each of our congregations. Even if your church doesn't have a website – a web search brings up a link that includes your church's address, picture, a map, and phone number. Additional information, including service times and media can be added.

Multiple members from your church can obtain a log-in to access a protected area where leadership information is contained. This can serve as a database for your congregation – you can list each member/phone/ address and print off lists and mailing labels from this information. All of this is at no cost to the individual church. Please call Julie at the District Office for more information

Background checks are available through the District Office at a cost of \$7.50 each. Some congregations use this service as they implement their Child Protection Policies (many insurance companies now require churches to have such a policy – and we all want to keep our children safe). The individual signs a permission form for the background check to be run and confidentiality is maintained. Please contact Kris Hawk for more information.
