There are two ways to submit nominations:

- (1) Online via the "2019 Nominations" link at the www.brethren.org/ac website. That is very helpful to us. You must provide the email address of the person you are nominating in order to submit the nomination online. We will send email to your nominees to invite them to submit their information online. We cannot consider those who do not respond. Please follow up with the persons you nominate to make sure they have received our email and contact us if they did not.
- (2) If you cannot submit online you may use the Elected Office Nomination Form and have your nominee fill out the Nominee Information Form-2019 to send it in via postal mail. Note that persons being nominated must sign the form. We must have their permission to consider them as possible nominees.

All nominations should be submitted to the Annual Conference Office via the online process or via postal mail to 1451 Dundee Avenue, Elgin, IL 60120 ... by December 1, 2018. The earlier, the better. Thank you for your help!
