News from Eden Church of the Brethren

Eden Church of the Brethren, Canton, set a goal this year to increase visibility and awareness in its community, to help folks know WE are here for them and that Eden CARES! The congregation is accomplishing this goal by inviting friends, neighbors and family members to any of 12 special events offered at the church through-out the year. Such fun activities as an Ice Cream Social in August, Eden's annual Easter EGGstravaganza the weekend before Easter, Summer Bible Camp in June, and *Trunk-or-Treat* in October are among these special events!





Also important is getting out INTO our community, allowing the congregation to have a presence at various township and village events (parades, festivals, celebrations) offered in the communities where Eden members live. One such event is *"Patriots in the Stadium,"* offered annually by Perry Township (Stark County), where many churches, organizations and merchants host booths at the Perry H.S. Stadium, along with an array of family-fun activities sponsored by the Township. Eden is gearing up for this event, held this year on Saturday, May 11.

However, whereas most other participating groups offer <u>something</u> (food, trinkets, etc.), Eden offers conversation, prayer and friendship. Last year many meaningful conversations were held with persons who perhaps never had even heard of Eden Church of the Brethren. This year the congregation is anticipating even more opportunities to serve, share, and care! And the members of Eden are always on the look-out for similar opportunities to participate in the many communities adjacent to the church.

Ashland First Church of the Brethren 2018 Hottle Grant Update



In March 2018, Ashland First Church of the Brethren applied for and received \$5,000.00 from the Northern Ohio District Hottle Grant Fund for roof improvements. A Sunday School wing added to the church in 1960 had a flat roof. Over the years, this roof required a lot of maintenance and had recently deteriorated to the point of major leakage. Our leadership team decided to install a pitched roof for future generations. The roof construction began in August 2018 and finished in February 2019. The total cost of the new roof was \$73,510.00. We are very thankful for the grant monies received from the district.

This has improved the appearance of our church and we can now use the sections we had to avoid due to leaks. We continue to work on enhancing and updating the church exterior. You will also see new windows in 2019, thanks to a grant fund gift from Trinity Lutheran Church in Ashland of \$10,532.49 toward our window replacement. We want the city of Ashland to know that things are alive and well at Ashland First! Thank you, Northern Ohio District Church of the Brethren for helping us to accomplish these goals. See the amazing transformation!



Church Improvement Loan

The Northern Ohio District exists to support our congregations in all aspects of ministry and church growth. Sometimes congregations are held back by building limitations or are overwhelmed by the cost of maintaining aging structures. Because of this great need, the District Board voted to set aside \$350,000 from the sale of the Water Street property to establish a new "Church Improvement Loan Fund".

Loans are now available for building and improvements and repairs to the main ministry property at 0% interest from the District for amounts up to \$20,000 with higher amounts taken into consideration on an individual basis. Examples of projects would include building additions, structural repairs, adding handicap accessibility, parking lot improvements, new restroom facilities, replacing an old furnace, adding air conditioning, new lighting, roof replacement, window replacement, painting, signage, etc. Access the Guidelines and Application form at <u>www.nohcob.org/loan</u> or call the District Office for more information.

Clarification on Annual Conference Compelling Vision Conversations

The Compelling Vision process began with a deep desire to find pathways to increased effectiveness in our ministry together as a denomination, in the midst of our diversity, and in some cases, division.

It is a call to pause our ongoing debates on the issues that divide us and step together into a place where we focus on respectful conversations to better understand the realities of our life together, discerning the way forward in God's plan for us. As the process has unfolded, events largely unrelated to the Compelling Vision process have led to escalated tensions around our division. As a result, some expectation has arisen that the Compelling Vision conversation at 2019 Annual Conference will directly address issues around homosexuality and same-sex marriage.

We understand that questions seeking understanding around both our commonality and our tensions are important as we explore our future of continuing to serve Christ together. However, the Compelling Vision process is not intended or designed to 'test', directly or indirecty, the desire of the body to maintain, change, or establish any particular official position/statement of the Annual Conference. Rather we seek to understand: Where are we united? Where can we build a bridge? Where do we need other options for a way forward outside our current framework?

Over all, we hope to ultimately answer this most important question: **How can we best strengthen the mission of Christ in our congregations...in our communities...in the world?** Working to answer this overarching question will help lead us to a compelling vision to be considered at the 2020 Annual Conference when the delegate body deliberates over the final product of the compelling vision process.

Isaiah prophesies the reign of God through Christ saying, "...He shall judge between the nations, and shall arbitrate for many peoples; they shall beat their swords into plowshares, and their spears into pruning hooks..." (Isa. 2:4)

May we come to Annual Conference focused expectantly on the Holy Spirit's powerful work among us. In the spirit of this prophecy, and as a people proclaiming Christ's reign in our lives, may we set aside our defensive and confrontational postures and come instead with a spirit prepared to till afresh the soil of our life together, so the seeds of God's Word can be planted among and through us aspiring to future abundant crops in God's Kingdom. May we find the way to passionately reclaim this rich mission of the church with renewed vision.

District Board chooses Forgiveness

None of us have a perfect record except at not being perfect. There are things that we have done and will do that we wish would have never been done, but the past cannot be undone. We are grateful for the gift of forgiveness through our Lord and Savior, Jesus.

In the Lord's Prayer Jesus tells us, "And forgive us our debts, as we forgive our debtors." Also, in Matthew 6:14-15 we are told "For if you forgive men their trespasses, your heavenly Father will also forgive you. But if you do not forgive men their trespasses, neither will your Father forgive your trespasses."

We are also reminded of the parable Jesus told about the unforgiving servant. He owed a debt he would never be able to pay back, and the King forgave his debt when he asked for mercy. Then he went out and found a fellow servant that owed him a small amount and he did not offer him forgiveness, even when he begged for mercy. We all need to follow the example of the King and extend forgiveness.

All of these things were brought to our mind as the Executive Committee and then the District Board discussed forgiving the balance of the debt owed to the District by Kristen Bair. Kristen was convicted of embezzling \$400,000 from the Northern Ohio District while she was employed as the District Secretary. Our confidence was shattered, our anger and grief ran deep, and the healing process has been long.

Kristen was sentenced in 2014, spent 6 months in jail and has been on probation since then. We have received periodic payments that have paid the debt down to approximately \$372,000.

During our April 2018 Executive Board Meeting Steve Simmons felt that it was time to grant forgiveness of this debt that was never going to be paid back. We took time for prayer and reflection. At the Fall Meeting, Steve was asked to write a letter of forgiveness and it was presented to the Executive Committee in February this year and passed on to the whole Board.

At the District Board meeting on March 9th, 2019 the motion to forgive Kris Bair the debt she owed was voted on by paper ballot and it passed unanimously.

The District has come a long way in this healing process from this deep wound and the next step is forgiveness!

We have signed a Release from the restitution order for Kristen Bair and are asking the court to release the Certificate of Judgment that set up the terms of the restitution order. We don't know what the court is going to do but we are doing our part by forgiving.

God through Jesus modeled this kind of forgiveness and in gratitude for all that has been forgiven us, we choose to forgive. It is our prayer that God's grace and love be known as we seek to live faithfully as followers of Jesus.

The Follow-Up

On May 17, 2019 at 8:35 am, Kris Hawk, District Executive, had a video visit with Kristen Bair through the Ashland County Jail's visitation system. She shared with Kristen Bair that the District Board had unanimously decided to release the balance of the debt that she owes to the Northern Ohio District.

Kristen immediately teared up and said "that's too generous" over and over. We talked about forgiveness. Kristen tearfully said "I am so sorry for what I did." She wiped tears from her eyes through most of the visit. **On May 21st** Kris Hawk received an email from Kristen Bair. Here are some excerpts of her words:

First off - I want to say thank you so incredibly much for the District's generosity regarding the debt I owe to the district and the congregations. I was so amazed and so thankful talking to you on Friday that all I could do is cry and pray after our visit. Especially in light of the last few days a huge weight has been lifted from my shoulders. God truly does work in mysterious ways and I am feeling incredibly blessed right now.

I would like you to pass along to the District Board how truly thankful, grateful and appreciative I am feeling. I feel horrible that I betrayed everyone's trust in me and I really do wish I had the means to make this right. All I can say is thank you, thank you, thank you from the bottom of my heart. I have no excuse for my actions, but I am working to forgive myself knowing God has already forgiven me.

And if everyone could say a prayer for Tyler and Jessie (her children) I would greatly appreciate it. Sincerely, Kris Bair
